Sub: KSFE Ltd -- The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act - 2013 -- Constitution of Internal Complaints Committees in the Company -- Reg.

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act –2013 stipulates that every employer of a workplace shall constitute a Committee to be known as the Internal Complaints Committee'. Internal Complaints Committee shall consists of minimum 4 members, including the Presiding Officer. Any change in the panel of Internal Complaints Committee due to substitution/addition shall be immediately informed to the P&HR department. The Act stipulates the following conditions with regard to the constitution of Internal Complaints Committee and it should be strictly adhered while effecting substitution/addition.

Presiding Officer who shall be a woman employed at a senior level at workplace from (i) amongst the employees.

Not less than two Members from amongst employees preferably committed to the cause of women or who have had experience in social work or have legal knowledge. (ii)

One member from amongst non-governmental organisations or associations committed to the cause of women or a person familiar with the issues relating to (iii)

Provided that at least one-half of the total Members so nominated shall be women.

(iv) The Presiding Officer and every Member of the Internal Committee shall hold office for such period, not exceeding three years, from the date of their nomination as may be specified by the employer.

The member nominated from outside the Company shall be paid at the rate of Rs.500/per each proceedings.

Internal Complaints Committee shall hold meeting once in six months even if there is no complaint as such. The Presiding Officer shall ensure that annual report is sent to the P&HR department in the following format.
